# FOR EXCHANGE, STUDY ABROAD, WORK TERMS, OR TRAVEL ABROAD PROVINCIAL HEALTH CARE INFORMATION

# **CANADIAN STUDENTS:**

\* Please be aware that the travel coverage offered through your health and dental plan is dependent on your provincial coverage being in place for the duration of your travel.

Most provinces require you to **extend your provincial coverage** or **provide notice of absence** if you are outside of the province for a set amount of time. Please be sure to contact your provincial health provider to inquire about travel restrictions and extending your coverage.

Your provincial coverage is based on your home province, and not necessarily the province in which you are living while you attend school. Please refer to your **provincial health card** to determine what province you need to contact.

## **INTERNATIONAL STUDENTS:**

\* Please be aware that the travel coverage offered through your health and dental plan is dependent on your provincial coverage, or equivalent being in place for the duration of your travel.

#### **DSU INTERNATIONAL HEALTH PLAN:**

There **are restrictions** to the travel coverage offered by the DSU International Health Plan and you may be required to apply for an extension of coverage. It is highly recommended that you obtain **written confirmation** from the DSU Health Plan Office that this coverage will be in effect during the entire trip duration.

### **DSU INTERNATIONAL COMPANION PLAN & MSI:**

If you have **opted out** of the DSU International Health Plan with MSI, you were **automatically enrolled** onto the Companion Plan. **MSI does not provide you any coverage outside the province of Nova Scotia.** However, the Companion Plan provides you with 31 days of coverage outside the province of Nova Scotia. Coverage under the Companion cannot be extended beyond 31 days.

If you plan to travel for longer than 31 days, you will be required to purchase additional travel coverage.

#### **PRIVATE COVERAGE:**

If you have your own private coverage, there **may be restrictions** to the travel coverage offered by your plan. It is highly recommended that you obtain **written confirmation** from your health plan provider that this coverage will be in effect during the entire trip duration.

#### **HOME COUNTRY:**

If you are travelling to your home country, please **contact** the DSU Health Plan Office for more details before you leave. There **are restrictions in coverage** while visiting your home country under the DSU International Health Plan and the DSU Companion Plan.
